# Gift aid explained...

If you are a UK taxpayer, Gift Aid allows us to **claim 25p for every £1** that your donated goods raise. Gift Aid lets us claim **25% more** whenever we sell a donated item in our shops at no extra cost to you



**Gift Aid** helps towards the cost of running the hospice each year

## Agency Agreement

I wish Wigan and Leigh Hospice to act as my agent in offering my goods for sale, at a charge of 1% commission plus VAT which shall be deducted from the proceeds of sale.

The goods which I am offering to Wigan and Leigh Hospice are my own to give and do not belong to another household

I am not acting as a business in bringing goods in for sale to any Wigan and Leigh Hospice shop.

As legal and beneficial owner of the goods until they are sold, I understand that I have the right to keep all of the net proceeds of the sale but can choose to donate all or part of the proceeds, if I wish.

I confirm that I am at least 18 years old and understand that this agency agreement is a legally binding contract.

I understand that if Wigan and Leigh Hospice are unable to sell any of the goods they will have the right to dispose of the goods as they see fit.

I agree that Wigan and Leigh Hospice will not be responsible for any loss or damage to any goods brought into the shop for sale.

I agree that Wigan and Leigh Hospice will NOT write to me to confirm donations, if the total value of the money raised, after deduction of Commission and VAT (Net Sales Proceeds), from the sale of my goods in any tax year is equal to or less than £100 and the Net Sales Proceeds will be treated as a donation to Wigan and Leigh Hospice.

I understand that Wigan and Leigh Hospice WILL contact me, if the Net Sales Proceeds are in excess of £100 to give me the opportunity to donate the proceeds in excess of £100.

I understand that Wigan and Leigh Hospice WILL send me an end of tax year letter, even if monies raised are less than £100, detailing the Net Sales Proceeds and Gift Aid reclaimed in that tax year.

Either I or Wigan and Leigh Hospice may terminate this Agreement at any time by written notice. Wigan and Leigh Hospice may vary the terms of this Agreement at any time by written notice to me.
